In respect to the Govt. Memo with reference cited and the attention of Principals in the address entry is invited to the subject cited, the ministry of Skill Development and entrepreneurship has come up with a scheme of “National Scheme on entrepreneurship Development” for imparting entrepreneurship education to students.

The ministry of Skill Development and Entrepreneurship, Government of India has requested the state Government to field request for proposal (RFP) to be the project Institute (PI) from credible educational/technical Institutes (Which include Polytechnics also) to be project institutes vide D.O letter No B12012/45/2015-SDE, Dt: 19-09-2016 from Sri. Rohit Nandan, IAS Secretary to GOI.

GOI has extended last date for receipt of application up to 15.10.2016.

The eligibility criteria for selection of project institutes is

- 2500 SFT Space or higher
- Allocate at least 2 Faculty /Facilitators in the first year and an additional Faculty /Facilitator from second year onwards.
- Have broadband connectivity of at least 100 MBPS.
- Possess necessary Audio/Visual equipment and computers.
- Enroll on an average minimum of 250 students under the project every year during the first four years.

Government of India will provide financial assistance to the selected Institutions to set up Infrastructure for delivering the programmes. Under the scheme the institutions will receive a grant of Rs. 9 lakhs for a period of 5 Years plus additional Rs. 3 Lakhs for infrastructure set up in Government institutions: Honorarium of Rs. 5000/- p.m. will be provided for each faculty facilitator and toward costs related to faculty training.

I would like to draw your kind attention to my request made vide DO No. B12012/ 45/ 2015- SDE dated 29.08.2016 for encouraging credible educational/technical (ITIs) institutions to field Request for Proposal (RFP) to be the Project Institute (PI) for imparting entrepreneurship education under 'National Scheme on Entrepreneurship Development' under Ministry of Skill Development and Entrepreneurship.

2. As informed and requested to you in above letter, the Regional Orientation Workshops to orient the interested institutions to the offerings of the Scheme were conducted from 5-9 September 2016 at five regional centers under this Scheme. The participation of the State Government Officials, Higher Educational Institutions and ITIs in the Regional Workshops have remained not very encouraging except from few of the States.

3. Keeping in view of the above, in order to give additional time for mobilization of credible institutions, the Ministry is now extending the last date of receipt of RFP for the Project Institutes from 26.09.2016 to 15.10.2016 despite the time constraint ahead to start the Course from 01.01.2017 in the selected Project Institutes. The Ministry has now taken decision to include Poly-techniques also as the Project Institute under this Scheme.

4. In the above regard, I request you once again to kindly issue an immediate advisory to the Secretary Higher and Technical Education, Secretary School Education, Secretary Labour & Employment and Secretary Industries to mobilize credible Educational/Technical/Vocational Institutions (both Govt. and Private) under them to field the RFP to be the Partner Institutes for implementation of this Scheme at www.msde.gov.in and www.niesbud.nic.in

5. I would also like to reiterate my offer to field the Resource Person from the Ministry, in case the State Government wants to organize the Orientation Workshop of the prospective institutions in above regard. The Secretary Ministry of Skill Development (MSDE), Government of India has communicated a new national scheme on Entrepreneurship Development vide ref cited. The scheme aims to create an enabling ecosystem for entrepreneurship development through entrepreneurship education and training. Duration of the scheme is for a period of 5 years(2016-17 to 2020-21).

2. The scheme targets to cover 7.10 lakh students in a span of 5 years through project institutes as shown in the table below

3. The eligibility criteria for selection of project institutes is

- 2500 SFT space or higher
- allocate at least 2 Faculty/Facilitators in the first year and an additional Faculty /Facilitator from second year onwards.
- Have broadband connectivity of at least 100 MBPS.

- Possess necessary Audio/Visual equipment and computers.
- Enroll on an average minimum of 250 students under the Project every year during the first four years.

4 Government of India will provide financial assistance to the selected institutions to set up infrastructure for delivering the programmes. Under the scheme the institutions will receive a grant of Rs.9 Lakhs for a period of 5 years plus additional Rs.3 Lakhs for infrastructure set up in Government institutions: Honorarium of Rs.5000/- p.m. will be provided for each faculty facilitator and towards costs related to faculty training.

6. The ministry (MSDE) has already floated the request for proposal (RFP) for empanelment of project institute on 16-08-2016. The last date for receipt of applications is 26-09-2016. The RFP is available on www.msde.gov.in and www.niesbud.nic.in (Copy enclosed). The Government of Telangana would like to get 30 IHLs, 5 Schools, 15 I.T.Is and 2 EDCs enrolled in the programme this year.

7. You are therefore requested to identify suitable institutions under your administrative control and ensure that they file their applications on the website mentioned above before 26-09-2016. The list of institutions which submit their applications may be communicated to Principal Secretary LET&F for further coordination.

Brief Note on National Scheme on Entrepreneurship Development (NSED)

Scheme Modalities:

Objectives:

- This Scheme envisages is to create an enabling eco system for entrepreneurship development. Duration of the Scheme (2016-17 to 2020-21)
- Target:
To cover 7.10 Lakh Students in a span of 5 years in 2200 in Institute of Higher Learning (IHL), 300 in Schools (10+2), 500 ITIs, 50 Entrepreneurship Development Cell (EDC) and 8 Skill Development Centres (SDCs)

Implementation:

- A) **Project Steering Committee (PSC)** chaired by Secretary, MSDE will constitute
- B) **Project Implementation Unit (PIU)** housed at NIESBUD at Noida, U.P. with the following Committee:-
 - 1) DG, National Institute for Entrepreneurship and Small Business Development (NIESBUD)
 - 2) National Director – National E-Hub (Member Secretary)
 - 3) Member – Internal Finance Wing, Ministry for Skill Development and Entrepreneurship (MSDE)
 - 4) Member – Wadhvani Operating Foundation
 - 5) Member – EDII, CEO Organization
 - 6) Member – CEO, Consultancy Firm (Monitoring & Evaluation)

C) This Scheme is implemented in the Field by National E-Hub through 5-Regional E-Hubs and 50-Nodal E-Hubs.

D) Methodology: Component wise Activities:-

- Component 1 : Educate and Equip potential and early stage Entrepreneurs
To Equip 2200-IHLs, 300-Schools, 500-ITIs, 50-EDCs, 8-SDCs to deliver Entrepreneurship Training Programme
- Component 2 : Connect Entrepreneurs in enabling networks of peers, mentors, funds and business services
To deliver networking in all aspects
- Component 3 : Support Entrepreneurs through Entrepreneurship Hubs (E-Hubs)
To Establish Regional, Nodal and project Institutes, MIS and Factory on Wheels
- Component 4 : Catalyze a culture shift to encourage Entrepreneurship
To create, drive, social entrepreneurship and mentor
- Regional Entrepreneurship Resource and Coordination Hubs (Regional E-Hubs)
Regional E-Hub will coordinate with IHL, Schools, ITIs and EDCs

- **Nodal Entrepreneurship Resource and Coordination Hubs (Nodal E-Hubs)**

To organise induction-cum-Orientation programme for ITIs

Eligibility: 1) Running Entrepreneurship programme for atleast 3 years
2) Having a Team of faculty trained in entrepreneurship
3) Access to atleast 10 mentors (within and/or outside the Institute)

- **Entrepreneurship Hubs (E-Hubs) in Project Institutions:**

The Course will be designed by Wadhvani foundation and the curriculum is designed:-

- a) **2200 –Institute of Higher Learning (IHLs)** :: Curriculum spans 2 +1 years i.e. 4 +2 semesters of 6 months each, the first 4 courses are compulsory for all the students, the fifth and sixth are taken by the willing entrepreneurial students only.
- b) **300 Schools** :: Two Modules – Foundation course and Advanced Courses of 15 hours each
- c) **500 Industrial Training Institutes (ITIs)** : Foundation course-15 hours and Advanced course-60 hours duration
- d) **50 Entrepreneurship Development Cell (EDCs)** : Basic course for 30 hours in short Term Modular course

- **Financial Assistance : (90% Government of India + 10% Wadhvani foundation)**

- a. In **Government Institutes** ~ **Rs.12 Lakhs** for a period of 5 years (including Rs.3 Lakhs as Infrastructure, Honorarium Rs.5000/- p.m. for each faculty facilitator and costs related to faculty Training.
- b. In **Private Institutes** ~ **Rs.9 Lakhs** for a period of 5 years (except the infrastructure set-up), Honorarium Rs.5000/- p.m. for each faculty facilitator and costs related to faculty Training.

- **Internal Resource Mobilization:**

Fee from Student for IHL is Rs.1000/- per student per Semester/course and Rs.300/- per course/module and this amount is expected to be spent towards effective and smooth functioning of the courses under the scheme. There are appropriate Fee concession for SC/ST/OBC/Minority and People with Disabilities.

- **Eligibility Criteria for all Institutes :**

- a) 2500 sft space or higher with Clear Ownership Title
- b) Equipment and Adequate Training facilities with minimum 30 computers
- c) Mandate to provide 50% Trained (Wage/Self Employment) and 70% in Self Employment

- **To be rolled-out by 26-09-2016**

- **Action Taken** : Department is in the process of Empanelment of Project Institute (ITIs, EDCs): As detailed in Page: 3

Action- Plan of the Department's Capability in Implementing the (NSED) Scheme:

- Department is imparting Craftsmen Training Scheme since 1962 and fully Equipped with latest Machinery & Equipment in **61 Government ITIs, in addition there are 247 Private ITIs**
- The Department is also successfully implementing the following Centrally Sponsored Schemes:
 - (1) Vocational Training Improvement Project (VTIP) World Bank Assistance
 - (2) Public Private Partnership Scheme (PPP)
 - (3) Left-Wing Extremism (LWE)
 - (4) Model ITI
 - (5) Prime Minister 15 point Programme and
 - (6) Modular Employable Skills (MES) under Skill Development Initiative Schemes, is being successfully implemented in the State by uplifting the Skill enhancement of un-qualified workers and **Trained 3897** so far.

All **60 Government ITIs** are Well-equipped with Latest Machinery and Equipment of World Class Standards and fully Trained **976 Instructors** are available and they are already imparting Skill Training in **32 Engineering and 10 Non-Engineering Trades under Craftsmen Training Scheme (CTS)** and **Centres of Excellence (CoE)** in addition to **Modular Employable Skills (MES)** scheme.
