The Director of Technical Education, Telangana State, Hyderabad in his letter 2<sup>nd</sup> read above has submitted that Mr. Battula Anil Raj S/o, B Mallesham, B.Tech, Civil, Ist Year has applied for transfer from Jyothishmathi Institute of Technological Science, Ramakrishna Colony, Karimnagar to Jyothishmathi Institute of Technology & Science, Nustulapur, Karimnagar in B.Tech, Civil, Ist Year in the Unfilled Vacancy, for the Academic Year, 2016-17, under Convener to Convener Quota.

The Director of Technical Education has submitted that, the above student & the Principal, Jyothishmathi Institute of Technological Sciences, Ramakrishna Colony, Karimnagar have stated that the above said student was admitted in Civil Engineering, B.Tech, Ist Year for the Academic Year, 2015-16 & detained in the 1st Year (i.e., 2015-16) due to shortage of attendance and he needs to be re-admitted. But, the Jyothishmathi Institute of Technological Science, Ramakrishna Colony, Karimnagar did not get Affiliation from the JNTUH for the Civil Engineering branch for the Academic Year, 2016-17, hence the request for transfer of the above said student to Jyothishmathi Institute of Technology & Science, Nustulapur, Karimnagar.

The Director of Technical Education has stated that, the request is justified because, the above student has to repeat the Ist year Civil Engineering branch, B.Tech., in Jyothishmathi Institute of Technological Sciences, Ramakrishna Colony, Karimnagar, but, this College did not get Affiliation from JNTUH for the Civil Branch for the Academic Year, 2016-17, hence his transfer is justified to be considered as a special case for transfer at the Ist Year level.

4. Both the Colleges have given NOCs and the proposed transfer is in the Unfilled Vacancy in Convener Quota.
