ORDER:

The Director of Technical Education, Telangana State, Hyderabad in his letter 2nd read above has submitted that the Registrar, JNAFAU, Hyderabad, while enclosing the NOCs and the syllabus studied, has requested to consider transfer of a student Mr. Mohith R.B, from SRM Ramapuram School of Architecture, Chennai to Sri Venkateshwara College of Architecture, in the 2nd year of B.Arch course, for the Academic Year, 2016-17, on Medical Grounds.

2. The Chairperson, Board of Studies for Architecture, Jawaharlal Nehru Architecture and Fine Arts University, Hyderabad has informed that the candidate has completed Semesters 1st & 2nd B.Arch in SRM University. Comparison of JNAFAU & SRMU Syllabi as below:

I Semester:

All Subjects of JNAFAU B.Arch 1 Semester are completed by equivalent subjects in SRMU.
(Computer Application-I has general and introductory topics thus is being taken as not mandatory).

The following extra subjects were also taken up:

- i. Mathematics of Architecture
- ii. English
- iii. Theory of Architecture
- iv. Art Appreciation
- v. NCC/NSS/NSO/Yoga

II Semester:

In the case of II Semester the following subjects of JNAFAU have not been covered:

- i. Building Materials-II
- ii. Structural Mechanics – II
- iii. History of Architecture – I
- iv. Surveying and Leveling

(P.T.O.)

The candidate needs to re-register for these when offered at the earliest possible and complete them before starting VII Semester, as per the Academic Regulations.

Extra Subjects covered in SRM in II Semester:

- i. History of India Architecture – Equivalent subject is in III Semester JNAFAU, as much it need not be repeated.
- ii. Communication Skills in English.

3. Both the Colleges have given NOCs and the proposed transfer is in the Unfilled Vacancy.

4. As per G.O.Ms.No.122, Higher Education (EC.2) Department, dated 01-09-2005, Para 4 (4) reads as follows:

“no transfers can be permitted from one University affiliated private college to another University affiliated private college as all the Universities in the State are not following uniform syllabus and uniform system of examination”

5. The Government, after careful examination of the matter and in relaxation of the conditions of para 4 (4) of the G.O 1st read above, hereby accord permission for transfer of Mr. Mohith R.B S/o Mr. Balaji R.C, Bachelor of Architecture, IInd Year(provided he is promoted to the IInd Year) from SRM Ramapuram School of Architecture, Chennai to Sri Venkateshwara College of Architecture, Hyderabad, in Bachelor of Architecture, II Year, in the Unfilled Vacancy, for the Academic Year 2016-17, on Medical Grounds, subject to the condition that he has to fulfill the Academic Regulations of JNAFAU, Hyderabad as mentioned at Para 2 above.

6. The Director of Technical Education, Telangana State, Hyderabad / Secretary, Telangana State Council of Higher Education, Hyderabad / Registrar, Jawaharlal Nehru Architecture and Fine Arts University, Hyderabad shall take necessary further action in the matter, accordingly.
