**Minutes of the Teleconference Conducted by the Commissioner Of
Technical Education, Telangana, with the Principals of all Government
Polytechnics, Secretary,SBTET and RJD(TE) on 31-01-2017 from 3.30 P.M.
onwards in the Prof.Jayashankar Conference Hall of Commissionerate Of
Technical Education, TS, Hyderabad on functioning of Govt. Polytechnics.**

The Commissioner of Technical Education, the officers of CTE and SBTET, T.S., Regional joint Director, Principals/OSDs and Heads of Section of Government Polytechnics attended the Teleconference and the Commissioner of Technical Education, T.S. deliberated and reviewed the various issues pertaining to the Academics, Budget, Biometric attendance etc.,

The following decisions were taken:

1. Remedial Teaching & Result Analysis and BMA :

The CTE has reviewed the status of Results and the conduct of remedial classes. The CTE has interacted with the Principals/OSDs/HOs of the following Govt Polytechnics:

➤ **GPT-Medchal:**

- The OSD, GPT, Medchal stated that he has identified the academically weak students for Remedial classes. The Meritorious students are made to interact with the academically weak students of that class/Particular subject in addition to the Teaching staff. The weak students are being given necessary coaching to improve the understanding of the subject, so as to pass and improving the results.
- The OSD stated that he is putting all efforts to reach the target of 90% results.
- CTE instructed the OSD to put all efforts to improve the results and also to keep access of CC cameras in the principal's room rather than in the Office.

Action: OSD, GPT, Medchal

➤ **GPT-Masab Tank-Hyd:**

- The Principal (FAC), GPT, Hyd. has stated that he has achieved 83% results in Nov/Dec'16 Examinations. His Polytechnic is having very good potential Staff & students. He is putting efforts to achieve 100% results in the March/April'17 Examinations. That his team will achieve top status in the Country.
- CTE appreciated the goal setting and desired that a vision & plan of action be desired to reach the goal and Department will support the same.
- Autonomous GPT is also a goal to work for.
- The CTE has interacted with the staff i.e. Mr. Prathap Reddy, Sr.Lect/Maths, N. Suresh, Lect/CME and Mr. Karthik, Lect/Auto who achieved 100% results in particular subjects.
- Mr. Prathap Reddy, Sr.Lect./Maths have stated that in practice he will complete the syllabus much earlier and conducted minimum two revisions and will give the more assignments.

Action: Principal(FAC), GPT, Masabtank

➤ **GPT- Cheriya:**

- RJD(TE) attended the Teleconference from GPT-Cheriyal.
- The Principal(FAC), GPT, Cheriyal, stated that academically weak students are identified and remedial classes are being conducted from 3.30 to 4.30 P.M every day. The polytechnic is 5 kms away from Cheriyal and due to transportation problem students are unable to attend the Remedial classes regularly and ten(10) students are regularly absent.
- The CTE has instructed the Principal(FAC) to inform the parents of the irregular students and conduct parents meeting, still not improved, then Memo/TC shall be issued.
- CTE expressed the displeasure over Poor Biometric Attendance in the GPT, Cheriyal

Action: Principal(FAC), GPT, Cheriyal

➤ **GPT-Nandipet:**

- The Principal, GPT, Nandipet, stated that his polytechnic is 27Kms away from Nizamabad, he arranged temporary hostel for 20 students and the permanent hostel building is under construction. Poor results in Maths & Basic Thermodynamics, No staff is staying in Nandipet.
- The CTE has directed the Principal to take all measures to conduct remedial classes and improve results, to engage staff for remedial coaching from nearby Engineering Colleges if required.
- The CTE has interacted with the staff of GPT, Nandipet i.e. Mr. A. Radha Krishna, Lect/Maths, in which subject the result is very poor and instructed to take measures to improve the results in ensuing exams
- CTE expressed the displeasure over Poor Biometric Attendance in the GPT, Nandipet.

Action: Principal(FAC), GPT, Nandipet

➤ **GPT- Kotagiri-**

- The OSD, GPT, Kotagiri has stated that the academically weak students and the subjects are identified and the remedial classes are being conducted.
- CTE observed that only 27% students have given Biometric Aadhar Based Attendance
- CTE Observed that the three contract lecturers i.e. Gangaram, Jayakala Pandiri and Sravani who have not given Biometric attendance.
- The CTE stated that if contract lecturers do not give Biometric attendance their salary shall not be claimed.

Action: Principal(FAC), GPT, Kotagiri

➤ **KDR GPT, Wanaparthi-**

- CTE reviewed the BMA of the staff. The Staff are informed that non recording of BMA on a particular day by any staff will be treated as unauthorized absence

Action: Principal(FAC), KDRGPT, Wanaparthi

The CTE has directed all the Principals, to follow the guidelines issued for conduct of Remedial classes, utilize the E-lessons / E-class rooms and the objective of all the Principals and heads of Sections and teaching staff must be

to improve the results in the ensuing exams by proper means. CTE reviewed the BMA of the Polytechnics and directed that the attendance of Staff and Students must be improved substantially.

Action: All Principals

2. Secretary, SBTET informed the Principals of following Institutions in which academic performance is very poor in III & V Sem exams of Oct/Nov-2016. He stated that the Principals shall see that the Remedial classes are to be conducted in these subjects such that there shall be an improvement of results in the ensuing Exams.


3. Budget:
