Minutes of the Teleconference Conducted by the Commissioner Of Technical Education, Telangana, with the Principals of all Government Polytechnics on 06-02-2017 from 4.00 P.M. onwards in the Prof.Jayashankar Conference Hall of Commissionerate Of Technical Education, TS, Hyderabad.

The Commissioner of Technical Education, the officers of CTE and SBTET, Telangana, Hyderabad, Regional joint Director of Technical Education, Hyderabad, Principals/OSDs and Heads of Section of Government Polytechnics attended the Teleconference and the Commissioner of Technical Education, Telangana, Hyderabad deliberated and reviewed the various issues pertaining to the Remedial Teaching, Result Analysis, Biometric Devices status & attendance and Campaign for POLYCET.

The following decisions were taken:

4. Remedial Teaching & Result Analysis and BMA :

The Secretary, SBTET has stated that the Government Polytechnics QQ, Old City Hyderabad, SDDGWTTI, Hyderabad, Vikarabad, Jogipet & Jogipet(W), Gomaram(Narsapur), Narayankhed, Kotagiri, Nandipet, Chegunta, Zaheerabad, Thirumalgiri, Kosigi, Gadwal, are the poor performing Polytechnics in 3rd semester examinations and have put in less than 35% of pass in the Oct/Nov '16 examinations.

The CTE has reviewed the status of Results and the conduct of remedial classes. The CTE has interacted with the Principals/OSDs and HOSs of the following Govt Polytechnics:

➤ **GPT-Thirumalgiri:**

- The Secretary, SBTET has stated that the overall pass % in 5th semester is 21%, i.e., from Civil Engg: out of 33 only 08 passed and from Mechanical Engg. out of 47 only 9 passed.

The CTE interacted with the Principal(FAC), GPT, Thirumalgiri, Mr. Raghavendar Reddy regarding poor performance and asked why remedial classes are conducted in Maths & Physics only w.e.f. 01.12.2016. The CTE noted that, maximum failures are from Design of Machine Elements, Estimating Costing and the subject teacher Mr. Venkateshwarlu applied leave. The CTE directed the Principal(FAC) to conduct remedial classes regularly in the identified subjects.

- CTE instructed the OSD/JD, O/o CTE, to frame charges against the Principal(FAC), GPT, Thirumalgiri for not conducting Remedial classes regularly for in Engineering subjects in spite of several instructions.

➤ **GPT-Kosigi-Mahaboobnagar:**

- The Secretary, SBTET have stated that the overall pass % in 5th semester is 34%, i.e., from Civil Engg: out of 25 only 07 passed and from Mechanical Engg out of 18 only 08 passed and from Electrical & Electronics Engineering out of 15 only 05 passed.
- The CTE interacted with the Principal(FAC), GPT-Kosigi, Mr. S.Srinivas regarding poor performance and asked why remedial classes are conducted in Maths, Physics & Chemistry only that too started very late from 19/01/2017. The Principal(FAC) stated that remedial classes for other subjects are commenced from 1st February'17 in subject codes M-304, EE-304, C/M/EE-301(common) & C-303.
- The Principal(FAC) replied that he came to the Polytechnic 06 months back and putting all efforts to improve discipline among students and results in the coming examinations.
- CTE instructed the OSD/JD O/o CTE, to frame charges against the Principal(FAC), GPT, Kosigi for delay in starting Remedial classes in spite of several instructions.

➤ **GPT- Chegunta:**

- The Secretary, SBTET have stated that the overall pass % in 5th semester is 33%, i.e., in Mechanical Engg out of 22 only 06 passed and in Electrical & Electronics Engineering out of 20 only 08 passed.
- The Principal(FAC), GPT, Chegunta, Mr. Chandra Sekhar, stated that the remedial classes are commenced from 15th November'16 and maximum failures are in Basic Thermodynamics and Manufacturing Technology subjects. The subject teacher Mr. Patel has taken students to QQ GPT for workshop classes and he is not available for Teleconference.
- The CTE has interacted with the Principal(FAC), GPT, Chegunta and asked how many students are improved after taking remedial classes and instructed the Principal(FAC) to make sincere efforts to improve results.

➤ **GPT-Narayankhed**

- The Secretary, SBTET have stated that the overall pass % in 5th semester is 27%, i.e., in ECE out of 10 only 05 passed and in Electrical & Electronics Engineering out of 16 only 02 passed.
- The Principal(FAC), GPT, Narayankhed, Mr. P.Raj Gopal Reddy, stated that the remedial classes are commenced from 19th November'16 and all students are admitted through spot admissions. The CTE opined that ECE results are quite better than EEE and interacted with the ECE Head Mr. Vidya Sagar. He said he is conducting remedial classes and slip test to improve the standard of students.

- The CTE interacted with the Mathematics lecturer Smt. Meenakshi who is the only lecturer to teach maths for all years. Then CTE instructed the Principal(FAC) to engage Guest Faculty to teach mathematics and to put in more efforts and directed the Principal(FAC) to have initiation and drive in conducting of remedial classes.

The CTE has directed all the Principals/OSDs, to take all steps to run Remedial classes seriously and to check the improvement through slip test etc, and Principals/OSDs will be personally held responsible for poor performance in ensuing Exams.

5. Campaign for POLYCET

The Secretary, SBTET has reviewed the status of applications registered for POLYCET-15 & POLYCET-16. He stated that during POLYCET-15 1,00,200 applications were received and during POLYCET-16 1,27,972 applications were received for the Entrance examination. The hike in applications is due to wide propaganda in all schools and distribution of pamphlets by the Principals of GPTs. Further he requested all the principals to give wide spread propaganda in schools about the Polytechnic education and to conduct the grand test in the districts on the dates to be decided by RJD(TE), Hyd/Secretary, SBTET, T.S. with the previous unused POLYCET question papers available with the SBTET/Polytechnics.

3. The CTE directed Mr. Sadiq Naick, AD, to take all measures for construction of Compound wall to the GPT, Nandipet and the problem faced by the Principal to be solved quickly regarding water stagnation in the campus.
