In continuation of this Office Memo under reference 3<sup>rd</sup> cited, the following instructions were given to the Principals of the (15) Govt. Polytechnics identified for NB Accreditation.

1. The Govt. Polytechnics which have attained the SAR Score greater than 650 were instructed to go ahead with the NBA Accreditation Registration Process.
2. The Govt. Polytechnics which have not attained the SAR Score greater than 650 but SAR has been prepared were instructed to seriously explore and identify areas of improvement and re-do SAR at the earliest.
3. The Principal, Dr. BRAGMR Govt. Polytechnic, Karimnagar was instructed to seriously attempt for drafting SAR for Computer Engineering Course
4. The Principal, S.S. Govt. Polytechnic, Zaheerabad was instructed to strengthen the EEE Program and gear up for NBA accreditation process.
5. The Govt. Polytechnics which have attained very less SAR Score for the programmes compared to the other Polytechnics instructed to expedite the preparation of SAR immediately and submit their explanation for delay.
6. The Principal, Govt. Polytechnic, Nizamabad has not submitted the SAR till to date.

In view of the above, the Principals of (15) Govt. Polytechnics have not submitted the above information till today. Hence they are requested to submit the updated status report on above points through Regional Joint Director (TE), Hyderabad with marking copy to the Secretary, SBTET, Telangana State in both hard and soft copies by 15.04.2017 without fail.
