ORDER:-

In the reference 5th read above, the Director of Technical Education(I/c), T.S., Hyderabad, has stated that due to ban on recruitments, the Government had accorded permission to engage (200) Workshop Attendants against the vacancies in the Government Polytechnics on Contract basis on a consolidated payment of Rs.3000/- per month vide G.O. 1st read above and subsequently it was enhanced from Rs.3000/- to Rs.4,100/- per month, vide G.O. 2nd read above and from Rs.4,100/- to Rs.7,700/- per month vide G.O. 3rd read above.

2. In the reference 4th read above, the Government have issued orders for the enhancement of the remuneration for Contract and Outsourced personnel of certain services in Government Departments and mentioned that in respect of the categories of services other than those specified in the G.O., which are having a fixed consolidated remuneration, the remuneration shall be fixed not exceeding 50% enhancement of the existing remuneration or the minimum of the time scale attached to the similar category of comparable post in the Revised Pay Scale 2015, whichever is less.

3. The Director of Technical Education(I/c), T.S., Hyderabad, vide reference 6th read above, has furnished the proposal for the enhancement of the remuneration of 149 Contract Workshop Attendants working in the Government Polytechnics, in terms of the orders issued in the G.O. 4th read above, not exceeding 50% enhancement of the existing remuneration which is less than the minimum of the time scale (Rs.15460-Rs.47330) attached to the similar category of comparable post in the RPS, 2015, as Rs.11,550/- i.e., Rs.7700/- (existing remuneration) (+) 50% of the existing remuneration, which is Rs.3850/-, totalling to Rs.11550/- per month.

4. After careful examination of the matter, the Government hereby enhance the remuneration of the Contractual Workshop Attendants working in Government Polytechnics in the State from Rs.7,700/- (Seven Thousand and Seven Hundred only) per month to Rs.11,550/- (Rupees Eleven Thousand, Five Hundred and Fifty only) per month in terms of the G.O 4th read above and accordingly the payment of the remuneration for the month of March, 2017 (to be paid on 01-04-2017) shall be made.

5. This Order is issued with the concurrence of the Finance (HRM.VII) Department vide their U.O.No.16094/07/HRM.VII/17, dt.09-02-2017.
