Telangana State Scheduled Castes and Scheduled Tribes Special
Development Fund (Planning, Allocation and Utilisation of Financial Resources) Act,
2017, has come into effect from financial year 2017-18. As per section 20(g) of the
Act 18 of 2017 the departments have to maintain scheme wise, district wise, village
wise and beneficiary wise details as may be prescribed, for transparency and
monitoring the progress of the implementation, expenditure, output and outcome
indicators as may be prescribed for Scheduled Castes Special Development Fund/
Scheduled Tribes Special Development Fund.

2. The Government is developing a robust SC/ST Development Fund Monitoring
system to track expenditure on these two funds. Centre for Good Governance (CGG)
has been entrusted with the development of a detailed SC/ST fund monitoring
system encompassing all the Government Schemes which has a component of
expenditure on SC/ST beneficiaries or work. The development of the portal is in
progress.

3. Pending completion of the portal, the departments are requested to maintain
the details of expenditure and individual beneficiaries Scheme wise, category wise,
in the enclosed proforma, in digital form these details will be required to be updated
on a real time basis for all the Schemes including CSS and furnish the data to CGG
through mail/Web service.
