TSEAMCET	Inter or its equivalent	40% those who are claiming BC and 45% for others in Group subjects

Minority candidates (Muslim/Christian) who have not qualified or not appeared in TSEAMCET (M.P.C Stream) & TSEAMCET (Bi.P.C Stream)-2017, are informed to apply to consider them for the leftover seats if any, after exhausting all the TSEAMCET (M.P.C Stream) & TSEAMCET (Bi.P.C Stream)-2017, qualified Minority candidates in Minority Engineering/Pharmacy colleges opting for admission through Convenor (S.W-I).

**The candidates are not eligible for fee reimbursement scheme.** The application shall be submitted in the proforma placed in the website <http://dtets.cgg.gov.in> with all the details like Name, Gender, Minority, Date of Birth, and marks obtained in qualifying examination (Intermediate or its equivalent), contact mobile number, address for communication, supported with Xerox copies of Study Certificates, Minority Certificate, Caste Certificate, Intermediate marks memos or its equivalent, Transfer Certificate, and Aadhaar card. The filled in application shall be accompanied with a demand draft for Rs 500/- towards processing charges and shall be drawn in favour of **Convenor, TSCET Admissions** payable at Hyderabad.

The application and demand draft can be submitted in person or sent by registered post/speed post/Courier to The Convenor, TSEAMCET-2017 Admissions, Sanketika Vidya Bhavan, Masab Tank, Hyderabad-500028 on or before 10-06-2017 by 5 PM. The envelope should be superscribed with the stream i.e., TSEAMCET (M.P.C Stream) /TSEAMCET (Bi.P.C Stream) - 2017 as applicable. The relative merit list of applied candidates will be placed in the website: <https://tseamcet.nic.in> before the commencement of admission counseling. **Minority Candidates who have secured ranks in TSEAMCET-2017 need not apply.** Applications with insufficient information and not satisfying the eligibility criteria will be summarily rejected.
