**Eligibility to appear for Advanced Supplementary diploma examination during May / June – 2017**

1. The Candidates shall be in regular rolls of final year during academic year 2016-17 and appeared for exams in March/April-2017.
2. The candidates should not have more than two (02) backlog subjects (Theory, Practical or Both) put together. i.e. from 1<sup>st</sup> to 6<sup>th</sup> semester.
3. The Candidates registered for advanced supplementary exam shall appear for examination at Govt. Institute of Printing Technology.
4. The Travelling and Accommodation charges required, if any, are to be met by the candidate only.
