In the G.O. under reference cited, Government has permitted to engage the services of (37) Junior Assistants and (162) Office subordinates on Outsourcing basis for the Academic Year 2016-17 in (18) new Government Polytechnics subject to the condition that the renewal shall be strictly based on actual requirement with reference to admissions and based on the similar conditions as stipulated in G.O. Ms. No. 402 Higher Education (TE) Department dt. 17.12.2016. The details as below:

2. This Office has sent a proposal to the Government for renewal of Outsourcing services of Junior Assistants and Office subordinates for the academic year 2017-18 vide ref 2<sup>nd</sup> and 3<sup>rd</sup> cited and orders of the Government awaited. The issue of renewal by Government will be done in due course & states that the orders are valid for the entire academic year.

3. In the above circumstance, the Principals of the (18) Government Polytechnics who have engaged the outsourcing staff in pursuance of the provisions G.O. 1<sup>st</sup> Cited, i.e. the Junior Assistants and Office subordinates on out sourcing basis in 2016-17 and who were on rolls during academic year 2016-17 are duly permitted to instruct the above outsourcing staff to report at respective institutes on 08.06.2017 in the same station where there were working as on the last working day of academic year 2016-17.

4. These orders are valid until the renewal process is completed for the academic year 2017-18. No new Junior Assistant and Office Subordinate shall be engaged under any circumstances.

5. The receipt of the memo shall be acknowledged.
