ORDER:

The Government of India, Department of Higher Education, Ministry of Human Resources Development, New Delhi, in their letter 1st read above, have requested to provide the following concessions to the Kashmiri migrants in the Educational Institutions till further orders:-

- I. Relaxation in cut-off percentage upto 10% subject to minimum eligibility requirement.
- II. Increase in intake capacity upto 5% course-wise.
- III. Reservation of at least one seat in merit quota in Technical/ Professional Institutions.
- IV. Waiving of domicile requirements.

2. In the reference 2nd read above, Government of Telangana have issued orders providing certain concessions to the Kashmiri migrants in the Professional Institutions during the Academic Year 2015-16 and the said concessions were extended for the Academic Year, 2016-17 vide reference 3rd read above.

3. In the reference 4th read above, the Commissioner of Technical Education, Telangana State requested to issue necessary orders for concessions to the wards of Kashmiri Migrants for admission into Professional and Technical Institutions for the Academic Year, 2017-18.

4. Having regard to the request of the Government of India and references 4th and 6th read above, the Government hereby extend the concessions mentioned in para(1) above to the Kashmiri Migrant students, for the Academic Year, 2017-2018, with regard to their admission into various Professional Institutions in Telangana State.

5. The Commissioner of Technical Education, Telangana, Hyderabad / Registrars of all Universities shall take necessary immediate action accordingly and report the number of students admitted under this category to the Ministry of Human Resources Development, Government of India / All India Council for Technical Education and State Government for creating supernumerary seats to that extent.


**Subject: Concession for the wards of Kashmiri migrants for admission during academic session 2015-16-reg.**

Sir(s)/Madam(s),

I am directed to refer to this Ministry's letter No. 3-1/2012-NER dated 4<sup>th</sup> June, 2014, regarding provision of certain concessions for the wards of Kashmiri migrants in the matter of their admission to the educational institutions in other parts of the country during the academic session 2014-15. As Kashmiri migrants continue to face hardships, it would be necessary to provide concessions to their wards for their admission. Accordingly, it has been decided with the approval of competent authority to extend following concessions to the Kashmiri migrants in the matter of their admission in your institutions till further orders:-

- (i) Relaxation in cut-off percentage upto 10% subject to minimum eligibility requirement.
- (ii) Increase in intake capacity upto 5% - course - wise.
- (iii) Reservation of at least one seat in merit quota in technical/professional institutions.
- (iv) Waiving of domicile requirements.
