ORDER:

The Commissioner of Technical Education, Telangana State, Hyderabad in her letter 2nd read above has submitted that Mr. J.V.Khushal S/o J.Ram Mohan has requested for transfer from SRM University, Kanchipuram District, Tamilnadu to CMR College of Engineering & Technology, Kandlakoya, Medchal, Affiliated to JNTUH, Hyderabad in the IInd Year, B.Tech (Mechanical) for the Academic Year, 2017-18 on medical grounds.

2. The Registrar, Jawaharlal Nehru Technological University, Hyderabad which is the University that has affiliated CMR College of Engineering & Technology, Kandlakoya, Medchal has furnished the equivalency of subjects studied by the student and he has stated that the candidate has to study the following subjects to meet the course structure requirement up to 2nd Year I Semester of B.Tech (Mechanical) as per CMR CET R15 Regulations:-

Even though the subjects were studied at the earlier Institution, he has to study them again if failed or not studied and not equivalent as per the CMR CET R15 Regulations to obtain the required credits. The candidate has to study and pass all theory and lab courses as per CMR CET R15 Academic Regulations and syllabus.

3. Both the Colleges have given NOCs and the proposed transfer is within 1% ceiling of Convener Quota.

4. As per G.O.Ms.No.122, Higher Education (EC.2) Department, dated 01-09-2005, Para 4 (4) reads as follows:-

"no transfers can be permitted from one University affiliated private college to another University affiliated private college as all the Universities in the State are not following uniform syllabus and uniform system of examination"

5. The Government, after careful examination of the matter and in relaxation of the conditions in para 4 (4) of the G.O 1st read above, hereby accord permission for transfer of Mr. J.V.Khushal S/o J.Ram Mohan, B.Tech (Mechanical), IInd Year(provided he is promoted to the II Year) has requested for transfer from SRM University, Kanchipuram District, Tamilnadu to CMR College of Engineering & Technology, Kandlakoya, Medchal, Affiliated to JNTUH, Hyderabad in the IInd Year,
