2. The Registrar, Jawaharlal Nehru Technological University, Hyderabad which is the University that has affiliated CMR Engineering College, Kandlakoya, Medchal has furnished the equivalency of subjects studied by the student and he has stated that the candidate has to study the following subjects to meet the course structure requirement up to II Year II Semester of B.Tech (Mechanical) as per JNTUH R15 Regulations:-

Even though the subjects were studied at the earlier Institution, he has to study them again if failed, or not studied them and which are not equivalent as per the JNTUH R15 Regulations to obtain the required credits. The candidate has to study and pass all theory and lab courses as per JNTUH R15 Academic Regulations and syllabus.

3. Both the Colleges have given NOCs and the proposed transfer is within 1% ceiling of Convener Quota.

4. As per G.O.Ms.No.122, Higher Education (EC.2) Department, dated 01-09-2005, Para 4 (4) reads as follows:-

"no transfers can be permitted from one University affiliated private college to another University affiliated private college as all the Universities in the State are not following uniform syllabus and uniform system of examination"

The Government, after careful examination of the matter and in relaxation of the conditions in para 4 (4) of the G.O 1<sup>st</sup> read above, hereby accord permission for transfer of Mr. K.Siva Harsha S/o K.Ramesh Babu, B.Tech (Mechanical), IIIrd Year(provided he is promoted to the III Year) from Manipal University, Jaipur, Rajasthan to CMR Engineering College, Kandlakoya, Medchal, Affiliated to JNTUH, Hyderabad in the IIIrd Year, B.Tech (Mechanical) for the Academic Year, 2017-18 on medical grounds, subject to the condition that he has to fulfill the Academic Regulations of JNTUH, Hyderabad as mentioned at Para 2 above and the student shall not be eligible to claim the Fee Reimbursement as the above said transfer is Inter State transfer.

6. The Commissioner of Technical Education, Telangana State, Hyderabad / Secretary, Telangana State Council of Higher Education, Hyderabad / Registrar, Jawaharlal Nehru Technological University, Hyderabad shall take necessary further action in the matter, accordingly.
