**Minutes of the video conference convened by the Commissioner of
Technical Education, with principals/OSDs of all Government Polytechnics
at 11.00AM on 27/11/2017.**

A video conference is convened by Commissioner of Technical Education, Telangana, Hyderabad to review the functioning of Government Polytechnics at 11.00AM on 27/11/2017. The meeting is chaired by the Commissioner of Technical Education.

The following decisions were taken after detailed deliberations:

I. Budget Utilization, Orientation & Clarification:

1. The CTE expressed displeasure in respect of those GPTs in which the expenditure is very poor inspite of repeated instructions. CTE directed all Principals to bestow their personal attention in implementation of welfare schemes effectively and see that no budget is lapsed during 2017-18 with due transparency and accountability. In spite of clear instructions given in the minutes of the last video conference dated 18-09-2017 that the exam fee shall not be collected from the SC and ST Students covered under the welfare schemes under any circumstances, but Principals did not follow the instructions and allowed the above students to pay the exam fee during Oct /Nov'2017 exam which is highly objectionable and Principal shall see the amounts are remitted to them with due Acknowledgement either by online / net banking facility.
Action: All Principals /OSDs

2. All Principals are instructed to maintain the list of beneficiaries under all schemes and submit the same along with Aadhar Number and other details as requested by SCDF department to CTE office immediately. Many principals have drawn the budget released under SCDF and other schemes. They are also requested to incur the expenditure immediately. Further principals are informed that expenditure will be monitored on weekly basis. Information shall be submitted in the proforma prescribed.

II. Implementation of Schemes.

3. Principal, GPT Kothagudem has expressed that there are savings under different schemes due to release of budget under SCDF. Hence, requested to accord permission to utilise the savings for other schemes. It will be examined at CTE level and informed in due course.
Action: AD(Tech)/DD(Tech)

4. Principal, GPT Medchal has informed that the welfare schemes introduced by department are very useful to students and it may be extended to all students.
5. CTE informed that Industrial visits for students shall be taken up in all polytechnics.
Action: All Principals /OSDs

6. CTE requested all principals to quantify the data, statistics and submit report to CTE's office on the effect of schemes in improving the results and retention of students.

Action: All Principals /OSDs

III. SRUJANA :

7. All principals are requested to monitor the implementation of SRUJANA programme in their respective polytechnic and make it a grand success. A meeting of District coordinators and state co-coordinators will be convened in the Second week of Dec'2017 as the Last date for finalization of awards is 20-12-2017 and award function is convened on 5-1-2018.

IV. NBA accreditation:

8. The secretary SBTET informed that principals are facing difficulty in obtaining the data of previous internal test papers and the process may take three years. In spite of all the constraints the principals of identified polytechnics shall bestow their personal attention in finalizing the SAR document.

V. Land Record details:

9. All principals are informed that they shall take necessary steps for updating of land details in revenue department records. Revenue department has announced schedule for team visits for updating land records. Hence, principals shall attend such meetings and see that land details are updated without fail.

VI Skill Development Centers.

10. All Principals shall see that SDCs offer certificate courses by utilizing webinar, MOOCs facility, arrange internships and campus placements which will improve employability and employment of/for student. All principals shall ensure that students leave their institute with at least two certificates in add- on- skills as instructed earlier.

Action: Principals

11. Secretary SBTET has informed that many polytechnics are not up loading the student records/ sessional marks/ Lab exam marks and informed about the difficulties in timely declaration of Results.

VII: Other issues:

12. Explanation shall be called from the principal , KDR GPT, wanaparthu for unauthorized absence on the day of video conference i.e., 27-11-2018

Action: DD (NT)

13. CTE directed that the a technical team shall be constituted to verify the procurements made with regard to machinery and lab equipment, and their specifications and installation and usage.

Action: DD (Tech)

14. Every institute shall be audited by competent team constituted by CTE. The team shall audit the Accounts and related matters, 2 months before the retirement of the principal of the institute concerned.

Action: DD (NT)

15. An action plan shall be submitted to CTE on the conduct of State meet for IPGSM-2017 for approval.
