All the Principals of the Government / Aided / Private un-Aided /2nd shift Polytechnics in Engineering colleges in the State of Telangana, are hereby informed that, the Government of India has enacted the Sexual Harassment of Women at Workplace (Prevention, Prohibition and Redressal) Act, 2013 Central Act No. 14 of 12013 to provide protection against Sexual Harassment of Women at Workplace and for the prevention and Redressal of Compliance of Sexual Harassment and for the matters connected therewith or incidental thereto and as per section 4(1) every employer of a work place shall, by an orders in writing constitute a committee to be known as the Internal Compliance Committee.

Therefore, all the Principals of the Government / Aided / Private un-Aided /2nd shift Polytechnics in existing Engineering colleges are here by instructed to constitute Internal Compliance Committee (ICC) as per provision stipulated under section 4 of the act.

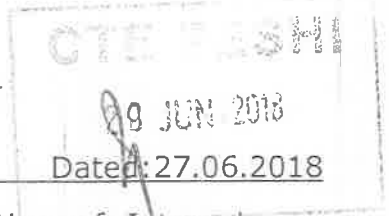

3. They are therefore requested to constitute ICC as per provision stipulated under section 4 of the act and also requested to direct all the HODs under administration control of their departments for constituting ICCs treating every department as a unit.
