With reference to the subject cited, wherein, the Government had
accorded orders by extending the concessions to the wards of Kashmiri
Migrant with regard to their admissions into various Professional and Technical
Institutions in Telangana State for the academic year 2018-19 till further
orders as shown below:

1. Relaxation in cut off percentage upto 10% subject to minimum eligibility
requirement.
2. Increase in intake capacity upto 5% course-wise.
3. Reservation of at least one seat in merit quota in Technical /
Professional institution.
4. Waiving off domicile requirements

In this regard, I request the Convener, TSEAMCET -2018 (Admissions)
to take up the admissions to the wards of Kashmiri Migrants (i.e. 5%
Supernumerary quota) by duly issuing a Public Notification in the Country for
inviting applications from the wards of Kashmiri Migrants.

Further, it is informed that, till-to-date (10) application have been
received by the CTE office, without any notification. Therefore, while
forwarding the applications received by this office, the Convener, TSEAMCET
admissions Hyderabad is requested to conduct the Kashmiri Migrant
admissions as per the guidelines laid down in the G.O. from the academic
year 2018-19 onwards.

ORDER:

The Department of Higher Education, Ministry of Human Resources Development, Government of India, New Delhi in the letter 1st read above, has requested to extend the following concessions to the wards of Kashmiri Migrants in the matter of their admissions in educational institutions till further orders:-

1. Relaxation in cut-off percentage upto 10% subject to minimum eligibility requirement.
2. Increase in intake capacity upto 5% course-wise.
3. Reservation of at least one seat in merit quota in technical/professional institutions.
4. Waiving off domicile requirements.

2. In the references 2nd to 4th read above, the Government of Telangana have issued orders providing the concessions mentioned in the para(1) above to the wards of Kashmiri Migrants in the Professional & Technical Institutions during the Academic Years, 2015-16, 2016-17 & 2017-18.

3. In the references 5th read above, the Commissioner of Technical Education, Telangana State, Hyderabad has requested the Government to issue necessary orders for concessions to the wards of Kashmiri Migrants for admission into professional and technical Institutions for the Academic Year, 2018-19 onwards till further orders.

4. Having regard to the request of the Government of India in the reference 1st read above and references 5th read above, the Government hereby extend the concessions mentioned in the para(1) above to the wards of Kashmiri Migrant, with regard to their admissions into various professional and technical Institutions in Telangana State, for the Academic Year, 2018-19 till further orders.

The Commissioner of Technical Education, Telangana State, Hyderabad/Registrars of all State Universities in Telangana shall take necessary action accordingly and report the number of students admitted under this category to the Ministry of Human Resource Development, Government of India/All India Council for Technical Education/Government of Telangana every year for creating supernumerary seats to that extent.
