

**MINUTES OF THE VIDEO CONFERENCE ON TELANGANAKU
HARITHA HARAM (THH) HELD BY THE CHIEF SECRETARY TO
GOVERNMENT ON 19.06.2018**

The salient features of the deliberations and decisions taken up during Video Conference by the Chief Secretary to Government with all the District Collectors and Forest Officers in the field on Telanganaku Haritha Haram on 19.06.2018 are as follows :-

- i. All the District Collectors are requested to complete the District Action Plan for 2018 planting and upload the details in TGFMS website.
- ii. They are requested to prepare the District Nursery Directory as being done every year and complete the matching and batching of seedlings for planting each site wise.
- iii. Since Gram Panchayat wise nurseries have to be raised from this year onwards, the required training to raise the nurseries will be imparted to all the concerned and Forest Department will provide the technical guidance. Detailed instructions will be issued by Commissioner, Rural Development Department in this regard.
- iv. It has been decided to develop all the 188 Forest blocks in 129 locations within HMDA limits and the details will be furnished by Prl. Chief Conservator of Forests & HoFF, TS, Hyderabad, to the District Collectors.
- v. Developmental activities as proposed by Forest Department should start in all the 59 Urban Forest Blocks earmarked for developing as Urban Forest Parks and Eco-tourism spots by 15th July, 2018.
- vi. In order to control monkey menace in the towns and villages, it is decided to plant up to 50% wild fruit bearing species in the forests to provide food for monkeys in future.
- vii. The District Collectors are requested to identify land for planting Eetha seedlings in the district. The Commissioner, Rural Development has advised the District Collectors to take up Eetha planting on farm bunds also under MGNREGs Scheme.
- viii. It has been decided to continue the 100 days relaxation for wages in case of nurseries under MGNREGs scheme, this year as well.
- ix. The District Collectors are requested to take up the sample survey for survival of plants planted during 2017 planting as per the instructions to be issued in the matter.

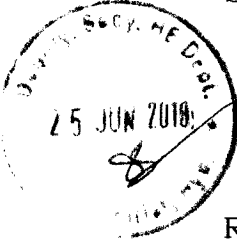

Minutes of the Meeting on Haritha Haaram Programme conducted by the Hon'ble Dy. CM and Minister for Education & Hon'ble Minister for Forest & Environment, B.C. Welfare on 21.06.2018 at 11.00 AM in the Chambers of the Dy.C.M &M(Edn), Telangana Secretariat, Hyderabad.

After detailed discussions, the following decisions were taken:-

- 1) Based on the Action Plan of the Forest department for **Haritha Haram Programme for 2018** all the HoDs of Education Department, i.e. C&DSE, CIE, CCE, CTE, Universities, and various educational institutions will take necessary action accordingly.
- 2) The District Collectors will identify the educational institutions which are having more than **Half Acre of land** available (apart from play ground) including Residential Schools, Model Schools, KGBVs and Government/ Local Body Schools. The Forest department can then take up **Block Plantation** in these institutions and the Rural Development department can **provide Caretakers under NREGS Programme**. The District Collectors shall conduct a meeting with the District Forest Officers, District Educational Officers, District Rural Development Officers and then identify such institutions and take further steps accordingly to implement the Haritha Haram programme, 2018.
- 3) The **Green Brigades** constituted in the schools will assist in the planting/ protection/ maintenance of the saplings planted under the programme in the institutional premises. Each Green Brigade can have students ranging from 11 to 51 depending on the students' strength of the institution including a team leader. **The Hon'ble Deputy Chief Minister & Minister for Education advised the Forest department to provide Uniforms (green and white combination), Harithaharam Caps, Scarfs, White Shoes to the Green Brigade Members**, which gives them good motivation and encouragement when they go for rallies to create awareness about the Haritha Haram Programme.

- 4) Already Environmental Science is incorporated in the School Curriculum. The Director, State Forest Academy and Director, SCERT may further work out **extra-curricular activities/ field visits/ eco-tourism etc.** to be taken up on this regard in the Schools and then can be encouraged in Junior Colleges, Degree College, Polytechnic Colleges and Universities also.
- 5) The Forest Department can provide **Audio Visual Aids like CDs/ Documentaries on Harithaharam/ Wild Life etc.**, which can be used in the Digital Classes for creating awareness and interest about the Environment among the students.
- 6) **The Hon'ble Minister for Forest & Environment, B.C. Welfare suggested** that the students should be motivated and encouraged to take up plantation of atleast one plant on the **occasion of their birthdays** to be celebrated in the institutions.
- 7) Instructions were already issued by the C&DSE & Ex-Officio, SPD, TSSA, Hyderabad to observe the **last Saturday of every month** as "Swachh Pathashala - Swachh Telangana" day which includes activities on awareness on personal hygiene; hand wash, cleanliness of kitchens and water tank and classroom premises, toilets etc by involving HMs, teachers, students, School Management Committees(SMC) Members, local NGOs etc. during the Post lunch session i.e **2:00PM to 4:30PM** in all Government/Local Body Schools. Now activities related to Harithaharam and Environment Awareness can also be taken up and called "**Swachh Pathashala - Haritha Pathashala**" on every last Saturday in the month.
- 8) Instructions were already given by Commissioner & Director of School Education to **include Project work on Haritha Haaram** topic in the Formative Assessment (FA) in July month and **five marks allotted** to the Classes 3rd to 10th for this project.
- 9) **Finally, the Hon'ble Dy.C.M. &M(Edn) directed that the Special Chief Secretary, (Education), Special Chief Secretary, (Environment, Forests, Science & Technology) and Prl. Chief Conservator of Forest & HoFF, shall conduct a meeting and video conference** with the Heads of the Education Department, Secretaries of Residential Schools and Forest department Officials to finalize the modalities and Action Plan for the Haritha Haaram Programme, 2018, in the educational institutions in the State.
