**Sub:-** TECHNICAL EDUCATION - ESTABLISHMENT - TSMS - Smt. C. Lavanya, Senior Assistant, Government Polytechnic, Sangareddy - Suspension from service- Orders - Issued.

**ORDER:-**

Whereas in the reference cited, the Principal, Government Polytechnic, Sangareddy has brought to the notice that Smt. C. Lavanya, Senior Assistant has been transferred from Government Polytechnic for Women (Minorities), Badangpet and reported on 01.07.2018 at GPT, Sangareddy and she has not been attending the institution from 14.07.2018 onwards. Therefore, her absence from duties without prior approval of the Higher authorities caused dislocation of Administration work in GPT, Sangareddy. This shows the negligence towards her duties attracts Rule 3 of Telangana Civil Services (Conduct) Rules, 1964.

2. And whereas, in the above circumstances, disciplinary proceedings against Smt. C. Lavanya, Senior Assistant, Government Polytechnic, Sangareddy are contemplated.

3. And whereas Competent Authority after careful consideration of the available material and having due regard to the circumstances of the case, is satisfied and it is necessary to place Smt. C. Lavanya, Senior Assistant, Government Polytechnic Sangareddy under Suspension.

4. Now, therefore, in exercise of the powers conferred by sub-rule (1) of Rule 8 of Telangana Civil Services (CCA) Rules, 1991 the undersigned hereby order that the said Smt. C. Lavanya, Senior Assistant, Government Polytechnic, Sangareddy is placed under suspension with immediate effect and she shall continue to be under suspension until the conclusion of the disciplinary proceedings.

5. It is further ordered that during the period this order remain in force, the Head Quarters of Smt. C. Lavanya, Senior Assistant, Government Polytechnic, Sangareddy shall not leave the Head Quarters without obtaining the prior permission of the undersigned.

6. Further the Principal, Government Polytechnic, Sangareddy is directed to draw and disburse the subsistence allowance for the suspension period under intimation to this office regularly.

7. The receipt of the Proceedings shall be acknowledged.
