7. He /she has to bear the entire course fee and other expenditure on his/her own and there shall not be any financial Commitment on the part of Government.
8. This does not guarantee they retention in the place, where they are working now or to the place of their choice on the pretext that there are doing do part time ( Open ), at Dr.B.R.Amedkar Open University, Hyderabad.
