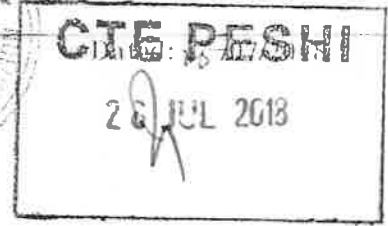

Sub:- Compliance of deficiencies/ adhering the norms of AICTE.

Sir,

During the Approval Process 2018-19, in the Institutions running Technical programmes, a number of deficiencies regarding land & building/builtup, instructional/administrative/amenities/ circulation area, faculty, anti ragging etc. were noted by EVC/SIC/SAC. Representative of the institutions made the submission and produced the documents to comply the deficiencies. In some cases, they submitted undertaking regarding barrier free environment/ installation of lift/ provision of ramp & toilet/ appointment of qualified principal/ salary as per sixth pay commission etc. before commencement of the current academic session. On Scrutiny it is found that some institutions have submitted their compliance and some of them have not complied so far. Non-compliance of deficiency is a violation of AICTE Norms.

2. In view of above, the institutions who have not submitted their compliance are directed to submit the same within two weeks from the date of issuance of letter, failing which necessary action will be initiated against the institutions for violation of AICTE Norms.

3. It has also come to the notice of AICTE that retrenchment of staff is being effected due to change of norms relating to Faculty-Student Ratio and there is a panic amongst teachers and staff in the institutions. This has been viewed very seriously by the AICTE and this would also be considered a violation of norms. In case any information regarding retrenchment of staff from the institution without any valid reason comes to the notice of AICTE, the same will be taken as a violation of norms and a stern action will be taken against those institutions. In this regard public notice No. Approval/06(03)/2018 posted in AICTE website on 11.07.2018 may be referred.

4. Besides, all the institutions are directed to adhere to the norms strictly as laid down in Approval Process Handbook.
