2. Under the Provisions of Rule 10 (a) of Telangana State and subordinate Services Rules, 1996, the Commissioner of Technical Education, Telangana, Hyderabad hereby order the following promotion to the post of Lecturer in Engineering and Non-Engineering as mentioned in the annexure enclosed.

3. The temporary appointment ordered above do not confer any right to the incumbent over the post and the same is liable for cancellation at any time without assigning any reason / notice what so ever.

4. The Principals of Government Polytechnics concerned are requested to relieve the individual immediately with instructions to report at their new stations, under intimation to this Office.

5. As per Rule 11 (b) of TS State and Subordinate Service Rules, 1996 as amended in G.O.Ms.No.145 G.A (Ser.D) Department, dt. 15.06.2004, they will be allowed 15 days of joining time from the date of receipt of the posting orders. If they fail to join the new post to which they are promoted within the said time limit or evade joining the post by proceeding on leave they will forfeit their right of promotion to the post for the present panel year. Their cases will be considered for promotion again in the next panel year however subject to availability of vacancies.

6. The Principals concerned are requested to intimate the dates of joining of the incumbents at their respective places.

7. The incumbent shall qualify in the special qualifying test to be conducted by the TSPSC.
