ORDER:

In the proceedings reference 1st read above, Lecturers working in the Technical Education Department, Telangana, Hyderabad were promoted as Senior Lecturers and posted in various Government Polytechnics but a few relinquished promotion.

2. In the circumstances and under the provisions of Rule 10 (a) of Telangana State and Subordinate Service Rules, 1996 Sri A. Varun Kumar, Lecturer in Mechanical, Government Polytechnic, Nalgonda whose name was approved by the DPC as reserved is temporarily promoted to the posts of Senior Lecturers in the AICTE Scale of Pay of Rs. 15600-39100 with an AGP 7000/- and posted in the existing vacancies as Senior Lecturer, Government Polytechnic, Nandipet.

3. As per Rule 11 (b) of TS State and Subordinate Service Rules, 1996 as amended in G.O.Ms.No.145 G.A (Ser.D) Department, Dt. 15.06.2004, they will be allowed 15 days of joining time from the date of receipt of the posting orders. If they fail to join the new post to which they are promoted within the said time limit or evade joining the post by proceeding on leave they will forfeit their right of promotion to the post for the present panel year. Their cases will be considered for promotion again in the next panel year however subject to availability of vacancies.

4. The Principal, Government Polytechnic, Nalgonda is requested to relieve / accept the promoted officer as per the postings ordered.

5. The Principals of the Institutions concerned are requested to send the compliance to this office promptly.
