The Commissioner of Technical Education, Telangana State, Hyderabad, in his letter 2nd read above has proposed for the transfer of Ms.PVS Manjusha Sekhar, B.Tech(CSE), IV Year from SVS Group of Institutions, Hanamkonda, Warangal District to Kodada Institute of Technology & Science for Women, for the Academic Year, 2018-19, on medical grounds.
