ORDER: -

In the references 1<sup>st</sup> to 3<sup>rd</sup> read above, Government permitted to engage Contract Lecturers in Govt. Junior Colleges; Govt. Degree Colleges and Govt. Polytechnics respectively and directed that the contract engagement shall be made for a maximum period of 10 months in an academic year.

2. In the references 4<sup>th</sup> to 6<sup>th</sup> read above, the Commissioner of Intermediate Education; the Commissioner of Collegiate Education and the Commissioner Technical Education, Telangana State, Hyderabad, respectively, furnished the proposals for the payment of honorarium for 12 months to the Contract Lecturers working in the Govt. Junior Colleges; Govt. Degree Colleges and Govt. Polytechnics.

3. Government after careful examination of the matter, hereby permit the Commissioner of Intermediate Education; the Commissioner of Collegiate Education and the Commissioner Technical Education, to pay the honorarium for a maximum period of 12 months in an academic year to the Contract Lecturers working in the Govt. Junior Colleges; Govt. Degree Colleges and Govt. Polytechnics in the State, with effect from this Academic Year, 2018-19.

4. The Commissioner of Intermediate Education; the Commissioner of Collegiate Education and the Commissioner Technical Education, Telangana State, Hyderabad, shall take further necessary action in the matter accordingly.
