**ORDER:**

In the reference 2<sup>nd</sup> cited, Sri R.Anjan Kumar a Private Employee has alleged that J.Yohan, OSD, Government Polytechnic, Kosgi has taken loan of Rs.1,00,000/- from him and not repaid the same therefore he has filed a fraudulent financial case in the Vth senior Civil judge Court,Hyderabad with E.P.No.259 of 2016 in OS No.725 of 2014 and got decree and in which the court has summoned the Principal, JN Govt. Polytechnic, Ramanthapur, Hyderabad to recover the amount from the salary of Sri J.Yohan, then Workshop Superintendent, JN Govt.Poly. Ramanthapur, Hyderabad and to remit the same to the court. After recovery of Rs.64,448/- due to transfer on promotion of Sri J.Yohan as Head of Mechanical Engineering to Government Polytechnic, Kosgi, the process of recovery was discontinued. Sri J.Yohan who is OSD, Government Polytechnic, Kosgi has not taken any steps to recover the dues from his own salary.

2. In view of the above, Sri J.Yohan, Head of Mechanical Section is relieved from the responsibilities of OSD, GP Kosgi and Sri K.Srinivasulu, Head of EEE Section placed on full additional charge of the OSD, Government Polytechnic, Kosgi in addition to his normal duties with immediate effect.

3. Sri K.Srinivasulu, Head of EEE Section is delegated with financial powers to operate both Government and Non-Government account of Government Polytechnic, Kosgi.

4. The OSD, Government Polytechnic, Kosgi, Hyderabad shall take further necessary action in the matter and submit compliance report to this Office.
