ORDERS:

In the reference 1st read above, the All India Council for Technical Education has made the regulations on (Major /Core Branch of Engineering / Technology and their relevant / appropriate courses leading to degree in Engineering / Technology), 2017 for recruitment to teaching positions. These shall apply to technical institutions conducting technical education and such other courses/ programs and areas notified by the Council from time to time. They shall come into force with effect from the date of their publication in the Official Gazette. Major/core branches of Engineering and Technology with nomenclatures of U.G and P.G degrees relevant for recruitment in teaching positions in the technical institutions were notified in F.N. 27/RIFD/pay/01/2017-18 Dated 28-402917 of AICTE.

In addition to the above, it is stated, that the BOG of the concerned institutions on the recommendation of duly constituted selection committee and with the approval of their respective State / UT /Central Government /University /DTE etc. as applicable may take appropriate decision on relevant qualifying degrees suitable for recruitment to teaching positions, especially keeping in view interdisciplinary nature of emerging technologies.

The applications have been invited from the Teachers of Government Polytechnics vide ref. 2nd cited for consideration of the appropriateness of the UG and PG qualifications possessed by the said teachers.

In view of the above, the following Committee has been constituted to take appropriate decision on the appropriateness of Post Graduation Degree to the UG Degree for promotions/award of CAS in teaching positions in the Department of Technical Education.
