ORDER:

There is a need to constitute State Human Rights Commission under sub-section (1) of section 21 of the Protection of Human Rights Act, 1993 (Central Act 10 of 1994) to exercise the powers conferred upon, and to perform the functions assigned to a State Commission under Chapter V of the said Act for the new State formed as per the Andhra Pradesh Reorganisation Act, 2014.

2. The State Government have, therefore, decided to constitute the State Human Rights Commission in the State of Telangana with the nomenclature "TELANGANA STATE HUMAN RIGHTS COMMISSION" (TSHRC, in short) as per the provisions of the Protection of Human Rights Act, 1993 (Act. No.10 of 1994).

3. Accordingly, the following Notification shall be published in an extraordinary issue of Telangana State Gazette, Dt:28.11.2019.

NOTIFICATION

In exercise of the powers conferred under sub-section (1) of section 21 of the Protection of Human Rights Act, 1993 (Central Act 10 of 1994), Government hereby constitute Telangana State Human Rights Commission to exercise the powers conferred upon, and to perform the functions assigned to a State Commission under Chapter V of the said Act.
