In terms of the Orders of the Government 1st read, instructions have already been issued that all the Govt./Aided/Private Polytechnic Colleges and Engineering / Professional (Engg/Pharmacy/MBA/MCA)/Universities (including IIIT, Basar) Colleges in Telangana State shall remain closed till 31.03.2020 as part of certain precautionary measures to prevent the spread of Corona Virus (COVID-19) in the State. Further, in pursuance of instructions issued in the review meeting 2nd read, the Registrars of the Universities at the address entry are hereby informed to furnish a compliance report in the following Format every day so as to ensure that none of University / Constituent / Private / Professional (Engineering / Pharmacy / MBA / MCA) Colleges, is functioning in adherence to the instructions issued under ref.1st read:-

Further, in the review meeting 2nd read, it has been clarified that as a rule all students must be vacated from the colleges /hostels concerned, however, the Managements of Professional (Engineering / Pharmacy / MBA / MCA) Colleges shall take steps to keep skeleton staff for the maintenance and up-keeping of the premises / regular administration work / sanitation on some rotation / roster basis so as to ensure that all the staff members are working on rotation basis equitably. Similarly, in respect of University / Constituent Colleges, all the staff and faculty members may be identified to work on rotation basis in order to take care of regular administration, scheduled University Examinations and development works in progress, duly following social distancing / personal hygiene measures already issued under ref.3rd read.

3. The Registrars of the respective Universities are hereby informed to submit the situation report in the format given above in Para-1 on daily basis, duly marking a copy to the Special Chief Secretary, Higher Education Department, Hyderabad.
