All the regulatory authorities namely the Registrars of Universities, the Secretary, Board of Intermediate; the Director of Technical Education, the Director, School Education; Secretary, Para Medical Board, the Director, Medical Education, and all the welfare officers in the State of Telangana are invited to the references cited, wherein certain instructions have been issued for registration of Colleges and verification of students in e-pass system to enable process the data of students who are admitted under Convener Quota through CETS for sanction of PMS.

2. The registration of Colleges and Students for the academic year 2020-21 in e-pass website have not yet been commenced. In the circumstances reported by the Commissioner, SCDD, TS, Hyd. in the ref. 3rd cited, there is a need to open the e-pass website for online registration of colleges and SC/ST/BC/EBC/MW /PHC students for sanction of Renewal and Fresh Post-Matric Scholarships for the academic Year 2020-21.

3. After careful consideration, Government hereby permit the Commissioner, SCDD, TS, Hyd., to open e-pass website **from the 14th October,2020 to 31 .12.2020** for Colleges and students registrations for sanction of renewal and fresh Scholarships for the academic year 2020-21.

4. All the regulatory authorities and Colleges managements must ensure that all Colleges & Students who wish to register in e-pass will upload their data **from the 14th October, 2020 to 31.12.2020** for sanction of renewal and fresh Scholarships for the academic year 2020-21.

5. All the students who are contemplate to get the benefit of Scholarships must visit the e-pass website at <http://telanganaepass.cgg.gov.in> and upload their data to register in e-pass website for sanction of fresh and renewal of Scholarships.

6. All the Welfare Departments must give wide publicity on the Registration process for Scholarship renewal and fresh Scholarships to Students and College Managements and ensure that the registration process be completed by **31st December, 2020.**
