ORDER:-

Under the provisions of Rule 10 (a) of Telangana State and Subordinate Service Rules, 1996, the Junior Assistants working in Government Polytechnics in Zone V,VI & City Cadre are temporarily promoted to the post of Senior Assistant in the Scale of Pay of Rs. 22460-66330 and posted at Government Polytechnic as shown against their names in the Annexure.

2. As per Rule 11 (b) of T.S., State and Subordinate Service Rules, 1996 adapted vide G. O. Ms. No. 196 G.A. (Ser. D) Departments, dt. 28.05.2016, they will be allowed (15) days time to join the promotion post from the date of receipt of posting orders. If they fail to join the new post to which they are promoted within the said time limit or evade joining the post by proceeding on leave they will forfeit the right of promotion to the post for the present panel year. Their cases will be considered for promotion again after a period of one (01) year from the date of offer of appointment/ promotion subject to availability of vacancies.

3. The Promotions ordered above are purely temporary and liable for cancellation, at any time, without neither assigning any reason there for nor do they confer any right or preferential treatment at the time of making their regular appointment to the posts.

4. The Principal of Government Polytechnics concerned are requested to relieve the individuals concerned immediately with instructions to report at their new stations under intimation to this Office. The date of joining of the individuals at their new stations may please be intimated through e-office.

5. The Promotion ordered above are subject the outcome from the High Court/Supreme Court on the OA's/W.P's, SLP's etc pending before them
