A Provisional Seniority List Administrative Officers working at Government Polytechnics, as on 01-09-2020 was prepared and communicated vide reference 1st cited to the individuals concerned. The following objections have been received and verified the objections & rectified.

1. **Sri M.Manohar Rao, Administrative Officer, Government Polytechnic, Station Ghanpur, (SL. No. 7 in the seniority list).**

He has stated that he has passed Account test for subordinate officer part-II with register No.20250711 held in the month of November , 2006 conducted by the APPSC Hyderabad . Hence he requested to rectify the same and incorporate into the final seniority list of A.O.

The request has been examined and the same is rectified in the seniority list.

2. **Sri K. Srinivas, Administrative officer, Government Polytechnic, Vikarabad.**

In his representation Sri K.Srinivas, A.O, GPT, Vikarabad has stated that the, ministerial staff working in the then Zones I to VI got promotions quickly on account of establishment of a number of Government Polytechnics in their Zones and consequential sanction of posts for each of those polytechnics. Whereas in the City, there was not expansion at all and the number of institutions remained at 5 (out of which two are state wide institutions) only which was obtaining in 1985. Further he stated that unfortunately, He belongs to the City cadre and it delayed his promotional opportunities, though he was appointed to the initial ministerial service post of Junior Assistant on 24th April, 1986. He became A.O. on 2nd July, 2013 Whereas in the remaining Zones, those who were appointed to the initial post of Jr. Asst/ Typist later to me became A.O earlier to me based on their Zonal seniority / in the category of office. Superintendent/Hostel Manager in their respective Zones. This analogous

situation caused heart burn to many ministerial staff working in the city cadre Zone. He is one among such unfortunate ministerial staff members. He thinks it is high time to set right such situation and do justice to him people like him.

Further he stated that in all Department in Telangana State following rule 34 read with rule 33 of TS State and subordinate service rules 1996(i.e. vertical seniority) is being followed in considering promotions to certain higher-level categories of Posts-Based on such practices prevalent in those Departments, vertical seniority is being followed in our Department also in promotions to the posts of Principals of Polytechnics for which the Heads of different subjects as also from different Zones are considered based on their seniority in the initial gazetted category of post as per service rules for TSTES rules issued in G.O.Ms.No. 178 Higher Education Dept. Dated. 09-12-2005. Similarly, if the vertical seniority in the initial cadre of Junior Assistant /Typist is considered, keeping the provisions of Rule 34 of the General Rules also the order, dated. 23th July, 1999 of the Hon'ble High Court in WP No. 24462 1998 and other W.P. son the issue relating to the seniority promotions of Dy. Executive Engineers in R & B Deponent for the purpose of promotions to the posts A.O/H.S/A.D(NT), such analogous situations could be avoided among the ministerial staff also.

In view of the above, he requested to consider review of his promotion to the post of Administrative officer and consider promotion to the post of Dy. Director (NT)/Deputy Secretary of SBTE&T, TS as per service seniority counting from first appointment(i.e as per rule 34 read with rule 33 of TS State Subordinate Service Rules, 1996 as applicable to the Teaching Staff in the Department).

His objection has been examined and rejected.

3. Smt BH. Svithri, Administrative Officer, Government Polytechnic, Sangareddy:

She has stated that her dated appointment and regularization in the present post of shown as 29-06-2013 instead of 02-07-2013. Hence she requested to incorporate her date of appointment in the present post as 02-07-2013.

Her objection has been examined and the same is rectified in the seniority list.

4. Sri T. Shankar, Administrative Officer, Government Polytechnic, Bellampally.

He has stated that his date of birth is mentioned as 01-03-1964 instead of 03-01-1964 and he passed Account Test passed for Subordinate Officers part -II. Hence he requested to correct date of birth as 03.01.1964 and incorporate the passing of Account Test details in the Final Seniority list of A.O's.

The request has been examined and the same is rectified in the seniority list.

5. Smt. B. Chandra Shekar, Administrative Officer, Government Polytechnic, Nalgonda.

He has passed Account Test passed for Subordinate Officers part -II and requested to includes his passed account test Part II details in the seniority list of AO's

The request has been examined and the same is rectified in the seniority list.

The provisional seniority List is finalized and the final seniority list of Assistant director (NT) / Administrative Officer as on 01-09-2020 is communicated here with to the individuals concerned.
